## **Refine the Vision Committee** (RVC)

Job Description, Role & Responsibilities

**Committee Leadership**: The *Refine the Vision Committee* (RVC) will be made up of representatives of the Crestone Planning Commission and other community representation including but not limited to, for example: business owners, residents, spiritual leaders, farmers/ranchers, town officials, etc.

The RVC will be made up of no more than fifteen (15) members (including Crestone Planning Commission members) from those who complete the form below and return it to Kim Smoyer, ScSEED (POB 102, Villa Grove, CO 81155) or email it to development@scseed.org.

The Crestone Planning Commission will select the members to serve on the RVC by February 1, 2012. The Committee will meet frequently during this planning process; this might mean as much as once a week for up to 6 to 8 weeks. Meetings will begin in February and continue through the middle of March 2012 (depending on the progress made at each meeting there is a chance the process will be lengthened or shortened).

**RVC Role**: The RVC has been tasked with refining the vision for the Crestone business district that has already been outlined in the Crestone Master Plan. The RVC will use the evaluations and outcomes from the Master Plan document to further define the overall scope and vision for the actual construction/reconstruction phases of the project.

The Planning Commission will provide the Crestone Town Trustees with recommendations to be reviewed and discussed at a publically scheduled Town Trustee meeting. Once the Town Trustees have reviewed the Planning Commission recommendations and have decided what the final plan will include, ScSEED will work to obtain funding to hire an engineer/architect to develop project plans and cost estimates. After the engineer/architect has completed his/her work and provided the cost estimates, ScSEED will work with the Town to secure funding for the construction project. Below is an outline of the CRP timeline.
